## **COOKIE POLICY**

TYPES OF DATA PROCESSED. Our company has read and applies the European Board Guidelines 5-2020 on consent and the Provisions of the National Authority on cookies.

WHAT ARE COOKIES, FOR WHAT PURPOSES ARE THEY USED?

Cookies are small files that are sent along with pages of this website and stored by your browser on the hard drive of your computer or other devices. The information stored in them may be sent back to our servers or to the servers of the relevant third parties during your next visit.

There are various types of cookies that can be summarised in the following table:

- 1. Technical or functional cookies, i.e. navigation or session cookies and strictly necessary for the functioning of the site or to allow the user to use the contents and services requested by them.
- 2. Analytical cookies, which allow us to understand how the site is used by users. These cookies do not collect information on the user's identity or any personal data. The information is processed in aggregate and anonymous form.

#### ON WHAT LEGAL BASIS ARE PERSONAL DATA PROCESSED?

The legal basis is, for the processing referred to in the previous paragraph, p. 1, the need to be able to perform what is requested by the interested party. With regard to the processing referred to in p. 4, your consent.

The processing referred to in p. 2 does not concern personal data, while those referred to in p. 3 are carried out by third parties.

#### WHAT ARE SCRIPTS, FOR WHAT PURPOSES ARE THEY USED AND ON WHAT LEGAL BASIS?

A script is a piece of program code used to make the website function properly and interactively. This code is executed on our server or on your device. No personal data is processed through the scripts.

#### WHAT IS A WEB BEACON, FOR WHAT PURPOSES IS IT USED AND ON WHAT LEGAL BASIS?

A web beacon (or pixel tag) is a small, invisible piece of text or image on a website that is used to monitor traffic on a website. To do this, various data about you is stored using web beacons. The legal basis for processing this data is your consent.

#### ACTIONS ON COOKIES
